BILL MILTON - MUSSELSHELL WATER SHED COALITION

It is for watershed management on the Musselshell. The 2011 flood did a lot of damage and they are working on issues that affect irrigators as well as recreationists. Milton said the coalition asked the legislature to help with funding and were denied funding so they are asking the counties to help with funding. Milton said he would like the County to consider becoming a partner with the coalition to help with funding to help local ranchers and also help the river and wildlife. Milton said various towns and counties donated anywhere from \$500 to \$1000 and that money was used as matching funds to ask FEMA to do a floodplain map for along the Musselshell and they received \$750,000.
